Late entries will receive goody bags on a first come – first served basis and t-shirts in remaining available sizes.

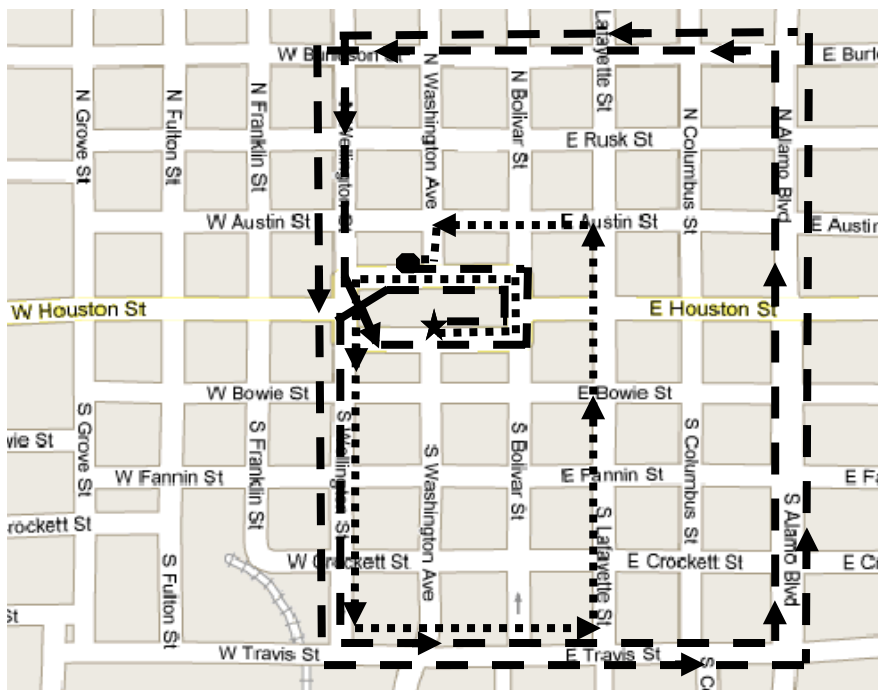
